An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.</p> <p>2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval to the left of the line provided, and write or print the name in the blank space provided for that purpose.</p> <p>3. To vote in FAVOR of a Question, fill in the oval to the left of the word YES. To vote AGAINST a Question, fill in the oval to the left of the word NO.</p> <p>4. Use only a black ink pen.</p> <p>5. If you make a mistake DO NOT ERASE. Ask for a new ballot.</p> <p>6. For Absentee Ballot voters: "A voter who receives an absentee ballot pursuant to section 1301 and whose ballot is not timely received and who, on election day, is capable of voting at the appropriate polling place may only vote on election day by provisional ballot."</p> <p>7.
